20 Respondent submits the following in response to Petitioner's Request for Case  
21 Management ("Petitioner's Request").

23 1. Petitioner's Request is unnecessary, omits material information and is a  
24 thinly-veiled effort to manipulate media coverage. On or about August 1, 2018,  
25 Respondent's counsel, Lance Spiegel, advised Laura Wasser that Respondent wanted to  
26 bifurcate the issue of marital status and have the divorce finalized before other pending  
27 issues were resolved. Mr. Spiegel asked whether Petitioner would agree to bifurcate  
28 marital status. Ms. Wasser responded that she would discuss the matter with her client

1 and then get back to Respondent's counsel. On August 6, 2018, a member of Petitioner's  
2 legal team requested that no action be taken on the bifurcation request for a week. Then  
3 on August 7, Petitioner filed her Request for a Status Conference to create the impression  
4 she (not Respondent) wanted to bifurcate. Based on Petitioner's Request, Petitioner does  
5 not object to Respondent's request to bifurcate and that issue can now be resolved by  
6 stipulation.

7  
8 2. There is no need for a Case Management Conference to schedule a hearing  
9 or filing deadlines regarding child support. Hearing dates are scheduled with Judge  
10 Ouderkirk and or with his assistant. Last week, counsel participated in a conference call  
11 with Judge Ouderkirk during which hearing dates were set and a status conference was  
12 scheduled for August 21, 2018. At that time, Petitioner's counsel made no mention of any  
13 child support issues and the sudden effort to schedule a hearing on that subject is  
14 calculated to increase the conflict. Respondent adamantly disputes the contention that he  
15 has not paid significant child support. Respondent has previously loaned Petitioner \$8.0  
16 million to assist her in purchasing her current residence and has paid over \$1.3 million in  
17 bills for the benefit of Petitioner and the minor children.
